PETITION FOR ADOPTION OF MINOR CHILD INSTRUCTIONS

Please be advised that the court cannot give you legal advice. This instruction sheet is to be used merely as a tool to assist you in correctly completing the Petition for Adoption. Should you require further explanation of the items on this form or legal questions regarding the adoption, please seek the assistance of an attorney who is licensed to practice law in the state of Ohio.

Also attached is a Copy of the Petition for Adoption of Minor Child Form with the correlating number below to assist you in completing your Petition for Adoption.

- 1. Child's name after the adoption.
- 2. Leave blank as the court will assign a case number.
- Minor child's birth name, if known.
 If child's birth name is not known write "unknown"
- 4. Minor child's name after adoption.
- 5. Petitioner (Adoptive Parent's) First name, middle name, and last name & age.
- 6. Second Petitioner (Adoptive Parent's) First name, middle name, last name & age, if there is a second petitioner. If there is not a second petitioner, type "n/a" or "not applicable".
- 7. Home address of the Adoptive parent(s) and the amount of time he/she has lived at that address.
- 8. Adoptive parent(s) marital status: unmarried, married, divorced or widowed.
- 9. If adoptive parents are married, type the month, day and year of the wedding & the city and state in which they were married
- 10. Relationship of the Adoptive Parent(s) to the child: Example step-parent, foster parent, grandparent, etc.
- 11. Child's birth name, if known.

- 12. Child's date of birth, if known.
- 13. Child's city and state of birth, if known.
- 14. If the child owns any personal and/or real property, please list the type of property and the value.
- 15. (A) Check this box if the child is living in the home of the adoptive parent, and list the date the child was placed there for adoption and who placed the child there. Example: Step-parent adoption use the date of the marriage as long as the child resided in the home at that time. Person who placed the child-parent. If a relative has custody or guardianship, use the date the court granted custody/guardianship and name of the court. If a foster child, list the date the child was placed in the home and the agency that placed the child in the home.
 - (B) Check this box if the child does not live in the home of the Adoptive Parent and list the child's address.
 - (C) Check this box if the child became available or potentially available for adoption prior to September 18, 1996.
 - (D) Check this box if you do not check box (C).
- 16. If you are submitting a certified copy of the child's birth certificate along with the Petition, please leave this line blank. If you will not be submitting the birth certificate along with the Petition please state the reason why. Example: The social worker will be providing the birth certificate at a later date, or the child was abandoned in a foreign country and there is not birth certificate, etc.
- 17. Check this box and list the name and address of the person or agency that has permanent custody of the child.
- 18. If the child had a court appointed guardian ad litem in a custody, divorce or children services case, please list the name and address of the guardian ad litem. If the child did not have a guardian ad litem, please type "n/a" or "not applicable", or if unknown type "unknown".
- 19. If a child services agency has permanent custody of the child, and if an attorney represented the child during those proceedings, please list the name and address of the attorney. If the child did not have his/her own attorney, please list "n/a" or "not applicable".
- 20. If a parent or an agency must consent to the adoption, write the name, relationship, and full address of the person who must consent to the adoption. Example: If Cuyahoga County Department of Children has permanent custody of the child, they will need to consent to the adoption. Also, pleaseindicate if that person or agency will be submitting a written consent. If you do not know the name of the juvenile court or the case number, write "unknown".

21. If you are alleging that consent is not needed, you will need to complete Item 21. If there is no father on the birth certificate & if no putative father has timely registered, check the first box in Item 21.

If you are alleging the consent of the child's biological parent is not required, list that person on line A and check the boxes under letter A, if they apply. If you are alleging consent of a second parent is not required, list that parent on line B and then check any boxes that apply under letter B.

If Children Services has permanent custody of the child and if you do not know the biological parent(s) information, you may leave this item blank. However, please make sure that Item 20 is completed.

22. Petitioner/Adoptive Parent(s) must type their name(s), address and telephone number.

Remember you must list your full middle name, not just a middle initial. Also, the Petition must include the original signature of each Adoptive Parent.

The attorney information only needs to be included if the Adoptive Parent is represented in this matter by an attorney.
